Sound of Freedom Golf Course (SOF) is a Department of Defense (DoD) golf course located on a military installation that allows restricted access for civilian golfers **to the Sound of Freedom Golf Course ONLY.**

Base access is a privilege and may be revoked or denied. Always be courteous to our Men & Women in uniform & Security personnel. **Inappropriate behavior is grounds for denial.**

All new and renewal requests must follow the procedures below.

Applications may be sent in by fax, mail or hand delivered by those with access. All personal information will be kept confidential and protected under the terms of the Privacy Act. Please fill out the application legibly and completely. Incomplete applications will not be processed. **One week after submission** of an application you may contact MCCS Review and Analysis office (252) 466-7022 to see if your application has been processed.

Once processed, applicants have 30 days to retrieve their pass from Pass and ID. A background check will be run prior to approval. When you arrive at security. Please bring your **Real ID** or **two (2) alternate forms of ID** (Driver's License, State ID, Passport, Certified Birth Certificate), **Vehicle registration** and **Proof of Insurance**. Negative findings on background checks will result in a denial of access. If you are approved for access to Marine Corps Air Station (MCAS), Cherry Point, Security will conduct an interview where conditions and restrictions of base access are reviewed and the applicant is asked to sign a form indicating agreement to the terms and conditions of access. You **MUST** show your pass to the guard at the gate. **Any passengers with you MUST have their own pass.** After being cleared through the gate, immediately proceed to the Golf Course when use of the facility is completed, you must directly exit the base. **Any deviation from this route may result in the loss of base entry privileges.**

All personnel and their property are subject to search while gaining access to or on MCAS. Seat belts must be worn at all times while on base. Talking and texting on a cellular phone while on your person and be prepared to present it when asked. Always stop for pedestrians. All personnel must follow Marine Corps policies while on base.
